Will the EU help Transnistria with natural gas?

Chisinau stresses that this is a temporary solution and has announced plans to introduce a two-year mechanism for supplying Transnistria with natural gas in the near future. The EU aid will help temporarily resolve the energy crisis in Transnistria and lower electricity prices for right-bank Moldova.

Does Transnistria need free gas?

However, this supply is insufficient to restore industrial production in the region to last year's levels. Without free gas supplies, Transnistria's economy is unsustainable.

Does Moldova still supply gas to Transnistria?

Since early February, Moldova has been supplying Transnistria with 3 million cubic metres of gas per day, restoring heating and allowing a return to gas-fired electricity generation. However, this supply is insufficient to restore industrial production in the region to last year's levels.

Will Transnistria face another energy crisis?

In the coming weeks, Transnistria may face another energy crisis. While the specifics of Chisinau's announced long-term solution for supplying gas to the left bank remain unclear, it will likely involve the gradual commercialisation of deliveries.
