Does China have an anti-dumping duty on solar glass?

By Implementing Regulation (EU) No 470/2014 (5) ('the original anti-dumping regulation'), the Commission imposed a definitive anti-dumping duty on imports of solar glass originating in the People's Republic of China.

Is TTG a dumping duty on solar panels?

The Directorate General of Trade Remedies (DGTR) has recommended an anti-dumping duty on imports of Textured Tempered Glass (TTG) from China and Vietnam. Commonly used in solar panels, TTG is also referred to as Solar Glass, Low Iron Solar Glass, Solar PV Glass, High Transmission Photovoltaic Glass, and Tempered Low Iron Patterned Solar Glass.

Which solar glass is subject to anti-dumping duty?

The solar glass subject to anti-dumping duty includes all glass fulfilling the abovementioned technical and physical characteristics, whether it is used for photovoltaic modules, flat photothermal energy collectors, furniture, to build greenhouses, or for other uses'.

Are solar glass imports a problem in India?

The Directorate General of Trade Remedies (DGTR) found that these imports, which account for 98% of India's solar glass needs, significantly undercut local prices and recommended the duties. What does SAMA say?
